A By-law to amend User Fee By-law 380-2003, as amended

WHEREAS By-law 380-2003 was passed pursuant to the *Municipal Act, 2001*, s. 391 (1) to impose fees or charges;

AND WHEREAS pursuant to Council Resolution <u>C272-2011</u>, approved by Council on December 14, 2011, it is deemed appropriate to amend By-law 380-2003;

NOW THEREFORE the Council of the Corporation of the City of Brampton **ENACTS AS FOLLOWS:**

- That By-law 380-2003 is hereby amended by replacing Schedule G, Transit Division Fees/Charges, Works and Transportation Department, with the Schedule set out in Appendix 1 to this by-law.
- 2. This by-law shall come into force and effect as of March 26, 2012.
