
To accept and assume certain

highways


WHEREAS it is deemed expedient to accept and assume
certain lands as parts of public highways;

NOW THEREFORE the Council of the Corporation of the
City of Brampton ENACTS AS FOLLOWS:

1. The lands conveyed to the Corporation of
the City of Brampton and described in
Schedule A hereto attached, be and the
same are hereby accepted and assumed as
part of the public highway system.

Council this *9th* day of 1979.
