To amend By-law 93-93,
 THROUGH HIGHWAYS, STOP SIGNS,
 NO PARKING, NO STOPPING

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by deleting from Schedule III thereto the following item:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Hartford Trail	The west limit of Kennedy Road South and the south limit of Steeles Avenue West

(2) by adding to Schedule III thereto the following item:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Hartford Trail	The south limit of Appleton Trail/Austin Drive and the west limit of Kennedy Road South

(3) by adding to Schedule IV thereto the following items:

STOP SIGNS

(6) by adding to Schedule XV thereto the following items:
