# BY-LAW

Number 66 - 2013

To provide for the re-division of the wards in the City of Brampton and the election of the members of Councils of The Corporation of the City of Brampton and the Regional Municipality of Peel and to repeal By-law 162-2002

WHEREAS The Corporation of the City of Brampton has (11) elected members of Council, as follows:

1. Head of Council called the Mayor elected by general vote; and
2. five (5) elected members called City Councillors, to be elected by wards in accordance with this by-law, as members of City Council only; and
3. five (5) elected members called Regional Councillors, elected by wards in accordance with this by-law, as members of both the City Council and Council of the Regional Municipality of Peel ("the Regional Council")

AND WHEREAS the City Council established a 10 ward system in 2002 and now considers it necessary to redivide the existing 10 wards into 10 new wards to provide for relatively equal and effective representation;

AND WHEREAS Council Resolution C053-2013 provides for the redivision of the wards in the City of Brampton, in accordance with Section 222(1) of the *Municipal Act, 2001*;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. The existing wards are hereby redivided, as described in Schedule A to this by-law.
2. This redivision shall be in effect from the 1<sup>st</sup> day of December 2014 and shall apply and govern the municipal election to be held in 2014 for the members of the City and Regional Council who will take office on the 1<sup>st</sup> of December 2014.
3. In the event the *Municipal Elections Act (Ontario)*, as amended is further amended to provide a term of office COMMENCING on a date other than the 1<sup>st</sup> day of December in an election year, this redivision shall be in effect on the date as set out in the amendment for the commencement of the term of office.

4. The members of the City Council shall be elected by wards in the following manner:

4.1 one (1) member to be called a City Councillor shall be elected in each of the five (5) two (2) wards electoral areas, as members of City Council only, as follows; and

- Wards 1 and 5
- Wards 2 and 6
- Wards 3 and 4
- Wards 7 and 8
- Wards 9 and 10

4.2 one (1) member to be called a Regional Councillor shall be elected in each of the five (5), two (2) ward electoral areas as members of both the City and Regional Council, as follows; and


- Wards 1 and 5
- Wards 2 and 6
- Wards 3 and 4
- Wards 7 and 8
- Wards 9 and 10

5. By-law 162-2002, is repealed.


6. Subject to the provisions of Section 222 of the *Municipal Act*, this by-law shall come into force on the day it is passed.

READ A FIRST, SECOND AND THIRD TIME AND PASSED IN OPEN COUNCIL THIS 27th day of March, 2013.

Schedule A – Ward Boundary Descriptions

## Schedule A

### **Boundaries of Ward 1**

COMMENCING at the centreline of the intersection of Main Street North and Bovaird Drive East;

THENCE easterly along the centreline of Bovaird Drive East to its intersection with the centreline of Highway 410;

THENCE southerly along the centreline of Highway 410 to its intersection with the centreline of Queen Street East;

THENCE westerly along the centreline of Queen Street East to its intersection with the centreline of McLaughlin Road;

THENCE northerly along the centreline of McLaughlin Road to its intersection with the centreline of Williams Parkway;

THENCE easterly along the centreline of Williams Parkway to its intersection with the centreline of Main Street North;

THENCE northerly along the centreline of Main Street North to the point of commencement.

### **Boundaries of Ward 2**

COMMENCING at the centreline of the intersection of McLaughlin Road and Mayfield Road;

THENCE easterly along the centreline of Mayfield Road to the east limit of CPR right-of-way;

THENCE northerly along CPR right-of-way to the dividing line between Lots 18 and 19;

THENCE easterly along the said dividing line to the mid-concession point between Hurontario Street and Kennedy Road North;

THENCE southerly along the said dividing line to the centreline of Mayfield Road;

THENCE easterly along the centreline of Mayfield Road to its intersection with the centreline of Highway 410;

THENCE southerly along the centreline to Highway 410 to its intersection with the centreline of Bovaird Drive East;

THENCE westerly along the centreline of Bovaird Drive East to its intersection with the centreline of McLaughlin Road;

THENCE northerly along the centreline of McLaughlin Road to point the of commencement.

### **Boundaries of Ward 3**

COMMENCING at the centreline of the intersection of McLaughlin Road and Queen Street West;

THENCE easterly along the centreline of Queen Street East to its intersection with the centreline of Queen Street East and Dixie Road;

THENCE southerly along the centreline of Dixie Road to the southerly City Limits;

THENCE westerly along the said City limits to the centreline of Hurontario Street;

THENCE northerly along the centreline of Hurontario Street to the centreline of its intersection with the centreline of Steeles Avenue West;

THENCE westerly along the centreline of Steeles Avenue West to its intersection with the centreline of McLaughlin Road;

THENCE northerly along the centreline of McLaughlin Road to the point of commencement.

**Boundaries of Ward 4**

COMMENCING at the centreline of the intersection of Mississauga Road and Queen Street West;

THENCE easterly along the centreline of Queen Street West to its intersection with the centreline McLaughlin Road;

THENCE southerly along the centreline of McLaughlin Road to its intersection with the centreline of Steeles Avenue West;

THENCE easterly along the centreline of Steeles Avenue West to its intersection with the centreline of Hurontario Street;

THENCE southerly along the centreline of Hurontario Street to the southerly City limits;

THENCE westerly along said City limits to its intersection with the centreline of Mavis Road;

THENCE northerly along the centreline to Mavis Road to its intersection with the centreline of Steeles Avenue West;

THENCE westerly along the centreline of Steeles Avenue West to its intersection with the centreline of Mississauga Road;

THENCE northerly along the centreline of Mississauga Road to the point of commencement.

**Boundaries of Ward 5**

COMMENCING at the centreline of the intersection of Mississauga Road and Bovaird Drive West;

THENCE easterly along the centreline of Bovaird Drive West to its intersection with the centreline of Main Street North;

THENCE southerly along the centreline of Main Street North to its intersection with the centreline of Williams Parkway;

THENCE westerly along the centreline of Williams Parkway to its intersection with the centreline of McLaughlin Road;

THENCE southerly along the centreline of McLaughlin Road to its intersection with the centreline of Queen Street West;

THENCE westerly along the centreline of Queen Street West to its intersection with the centreline of Mississauga Road;

THENCE northerly along the centreline of Mississauga Road to the point of commencement.

**Boundaries of Ward 6**

COMMENCING at the centreline of the intersection of Winston Churchill Boulevard and Mayfield Road;

THENCE easterly along the centreline of Mayfield Road to its intersection with the centreline of McLaughlin Road;

THENCE southerly along the centreline of McLaughlin Road to its intersection with the centreline of Bovaird Drive West;

THENCE westerly along the centreline of Bovaird Drive West to its intersection with the centreline of Mississauga Road;

THENCE southerly along the centreline of Mississauga Road to its intersection with the centreline of Steeles Avenue West;

THENCE easterly along the centreline of Steeles Avenue West to its intersection with the centreline of Mavis Road;

THENCE southerly along the centreline of Mavis Road to the southerly City limits;

THENCE westerly along the said City limits to its intersection with the centreline of Winston Churchill Boulevard;

THENCE northerly along the centreline of Winston Churchill Boulevard to the point of commencement.

**Boundaries of Ward 7**

COMMENCING at the intersection of the centreline of Highway 410 and Bovaird Drive East;

THENCE easterly along the centreline of Bovaird Drive East to its intersection with the centreline of Bramalea Road;

THENCE southerly along the centreline of Bramalea Road to its intersection with the centerline of Clark Boulevard;

THENCE easterly along the centreline of Clark Boulevard to its intersection with the centreline of Torbram Road;

THENCE southerly along the centreline of Torbram Road to the southerly City limits;

THENCE westerly along said City limits to its intersection with the centreline of Dixie Road;

THENCE northerly along the centreline of Dixie Road to its intersection with the centreline of Queen Street East;

THENCE westerly along the centreline of Queen Street East to its intersection with the centreline of Highway 410;

THENCE northerly along the centreline of Highway 410 to the point of commencement.

**Boundaries of Ward 8**

COMMENCING at the intersection of the centreline Bovaird Drive East and Bramalea Road;

THENCE easterly along the centreline of Bovaird Drive East which then becomes Castlemore Road;

THENCE easterly along the centreline of Castlemore Road to its intersection with the centreline of The Gore Road;

THENCE southerly along the centreline of the The Gore Road to its intersection with the centreline of Ebenezer Road;

THENCE easterly along the centreline of Ebenezer Road to the easterly City limits (Highway 50);

THENCE southerly along the centreline of the said City limits (Highway 50) to the southerly City limits;

THENCE westerly along the said City limits to its intersection with the centreline of Finch Avenue;

THENCE northerly along the centreline of Finch Avenue to the southerly City limits;

THENCE westerly along the said City limits to its intersection with the centreline of Torbram Road;

THENCE northerly along the centreline of Torbram Road to its intersection with the centreline of Clark Boulevard;

THENCE westerly along the centreline of Clark Boulevard to its intersection with the centreline of Bramalea Road;

THENCE northerly along the centreline of Bramalea Road to the point of commencement.

#### **Boundaries of Ward 9**

COMMENCING at the intersection of the centreline of Highway 410 and Mayfield Road;

THENCE easterly along the centreline of Mayfield Road to its intersection with the centreline of Torbram Road;

THENCE southerly along the centreline of Torbram Road to its intersection with the centreline of Bovaird Drive East;

THENCE westerly along the centreline of Bovaird Drive East to its intersection with the centreline of Highway 410;

THENCE northerly along the centreline of Highway 410 to the point of commencement.

#### **Boundaries of Ward 10**

COMMENCING at intersection of the centreline of Torbram Road and Mayfield Road;

THENCE easterly along the centreline on Mayfield Road to easterly City limits (Highway 50);

THENCE southerly along the centreline of the said City limits (Highway 50) to its intersection with the centreline of Ebenezer Road;

THENCE westerly along the centreline of Ebenezer Road to its intersection with the centreline of The Gore Road;

THENCE northerly along the centreline of The Gore Road to its intersection with the centreline of Castlemore Road;

THENCE westerly along the centreline of Castlemore Road which then becomes Bovaird Drive East;

THENCE westerly along the centreline of Bovaird Drive East to its intersection with the centreline of Torbram Road;

THENCE northerly along the centreline of Torbram Road to the point of commencement.
