# BY-LAW

Number 68-95

To authorize the execution of an agreement with The Regional Municipality of Peel respecting Woodhill Pioneer Cemetery

The Regional Municipality of Peel has requested that part of Woodhill Pioneer Cemetery be closed and the remains disinterred in another part of the Cemetery, in order that the lands might be sold to the Region to accommodate the widening of Airport Road.

The Council of The Corporation of the City of Brampton supports the Region's request, subject to the necessary approvals under the Cemeteries Act (Revised) being obtained.

**NOW THEREFORE**, the Council of The Corporation of the City of Brampton **ENACTS AS FOLLOWS:**

1. The Mayor and Clerk are hereby authorized to execute an agreement with The Regional Municipality of Peel, in a form approved by the City Solicitor, to provide that the Regional Municipality of Peel shall pay all costs associated with the proposed closure of the part of Woodhill Pioneer Cemetery shown as Part 1 on Plan 43R-20896, the disinterment of human remains from the said Part 1 and the abutting road allowance and the reinterment of the human remains in the remaining part of Woodhill Pioneer Cemetery in accordance with the provisions of the Cemeteries Act (Revised).

**READ a FIRST, SECOND, and THIRD TIME, and PASSED** in Open Council this 27th day of March, 1995.
