# BY-LAW

Number 70-86

To amend By-law 149-83  
(to regulate, supervise and  
govern the parking of vehicles  
on municipal parking lots

The council of The Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 149-83, as amended, is hereby further amended:

(1) by deleting from the specified columns of Schedule B thereto the following items:

<u>COLUMN 1</u> <u>PARKING LOT NAME</u>	<u>COLUMN 2</u> <u>PARKING LOT LOCATION</u>	<u>COLUMN 3</u> <u>FEE</u>
Rosalea Parking Lot	East side of Union Street opposite Nelson Street East (see Plan 2)	20¢ for each hour or \$10.00 for each calendar month or part thereof

(2) by adding to the specified columns of Schedule B thereto the following items:

<u>COLUMN 1</u> <u>PARKING LOT NAME</u>	<u>COLUMN 2</u> <u>PARKING LOT LOCATION</u>	<u>COLUMN 3</u> <u>FEE</u>
Rosalea Parking Lot	East side of Union Street opposite Nelson Street East (see Plan 2)	40¢ for each hour or part thereof, or \$20.00 for each calendar month or part thereof

(3) by deleting from the specified columns of Schedule C thereto the following items:

<u>COLUMN 1</u> <u>PARKING LOT NAME</u>	<u>COLUMN 2</u> <u>PARKING LOT LOCATION</u>	<u>COLUMN 3</u> <u>FEE</u>
Queen's Square Parking Lot	Between California Street and East Service Road and from Hannah Street to Union Street (see Plan 3)	20¢ for the first hour 20¢ for the second hour 30¢ for the third hour 50¢ for each successive hour  <u>or</u> \$20.00 for each calendar month or part thereof.
George Street South Parking Lot	Between Queen Street West and Wellington Street and Main Street South to George Street South (see Plan 4)	20¢ for the first hour 20¢ for the second hour 30¢ for the third hour 50¢ for each successive hour  <u>or</u> \$20.00 for each calendar month or part thereof.

(4) by adding to the specified columns of Schedule C thereto the following items:

<u>COLUMN 1</u> <u>PARKING LOT NAME</u>	<u>COLUMN 2</u> <u>PARKING LOT LOCATION</u>	<u>COLUMN 3</u> <u>FEE</u>
Queen's Square Parking Lot	Between California Street and East Service Road and from Hannah Street to Union Street (see Plan 3)	40¢ for the first hour, 40¢ for the second hour, and 50¢ for each successive hour or part thereof  <u>or</u> \$35.00 for each calendar month or part thereof.
George Street South Parking Lot	Between Queen Street West and Wellington Street and Main Street South to George Street South (see Plan 4)	40¢ for the first hour, 40¢ for the second hour, and 50¢ for each successive hour or part thereof  <u>or</u> \$35.00 for each calendar month or part thereof.

- (5) by the deleting from Schedule C thereto the section entitled "Hours of Operation for both the Queen's Square and George Street Parking Lots, and substituting therefor the following:

"Between the hours of 8:00 in the morning and 7:00 o'clock in the evening on Mondays, Tuesdays, Wednesdays and Thursdays, and between the hours of 8:00 o'clock in the morning and 9:30 o'clock in the evening on Fridays."

- (6) by deleting section 5 (2) therefrom, and substituting therefor the following:

"Where a motor vehicle operated by or conveying a physically handicapped person properly displays a valid identifying marker issued in accordance with the provisions of By-law 193-83, the owner and driver of said vehicle are exempt from the provisions of section 5 of this by-law pertaining to the parking of motor vehicles in or on any parking lot set out in Column 1 of Schedule B"

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL,
