To amend By-law 93-93 to regulate use of highways and parking in the City of Brampton

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

- 1. By-law 93-93, as amended, is hereby further amended as follows:
  - (1) by deleting from the specified columns of Schedule III thereto the following items:

### **THROUGH HIGHWAYS**

COLUMN 1
HIGHWAY
BETWEEN

Lockwood Road
The north limit of the road and the north limit of Drinkwater Road

(2) by deleting from the specified columns of Schedule IV thereto the following items:

## **STOP SIGNS**

COLUMN 1 INTERSECTION	COLUMN 2 FACING TRAFFIC
Kings Cross and Knightsbridge Road	Northbound on Kings Cross Road
Kings Cross and Knightsbridge Road	Eastbound on Knightsbridge Road
Kings Cross and Knightsbridge Road	Southbound on Kings Cross Road
Kings Cross and Knightsbridge Road	Westbound on Knightsbridge Road

(3) by adding to Section 2 thereto the following items:

"<u>fire chief</u>" means the Fire Chief of the Corporation of the City of Brampton or such person as he may designate to carry out his duties under this by-law.

"<u>fire route</u>" means any private roadway designated by the Fire Chief under the Fire Marshalls Act, R.S.O. 1990, F. 17.

(4) by adding to the specified columns of Schedule III thereto the following items:

Chadwick Road	The north limit of Carrie Crescent and the west limit of Lockwood Road
Herkes Drive	The east limit of Lockwood Road and the west limit of Drinkwater Road
Kitto Court	The south limit of Herkes Drive and the south limit of the road
Lockwood Road	The south limit of Queen Street West and the north limit of Drinkwater Road

(5) by adding to the specified columns of Schedule IV thereto the following items:

### **STOP SIGNS**

COLUMN 1 INTERSECTION	COLUMN 2 FACING TRAFFIC
Kings Cross Road and Knightsbridge Road	Northbound on Kings Cross Road
Kings Cross Road and Knightsbridge Road	Eastbound on Knightsbridge Road
Kings Cross Road and Knightsbridge Road	Southbound on Kings Cross Road
Kings Cross Road and Knightsbridge Road	Westbound on Knightsbridge Road

Subsections (1), (2), (4), and (5) of this by-law shall not come into force until approved by the council of The Regional Municipality of Peel. 2.

- 1. By-law 93-93, as amended, is hereby further amended as follows:
  - (1) by deleting from the specified columns of Schedule III thereto the following items:

(2) by deleting from the specified columns of Schedule IV thereto the following items:

### STOP SIGNS

Kings Cross and Knightsbridge Road	Northbound on Kings Cross Road
Kings Cross and Knightsbridge Road	Eastbound on Knightsbridge Road
Kings Cross and Knightsbridge Road	Southbound on Kings Cross Road
Kings Cross and Knightshuidge Road	Westbound on Knightsbridge Road

- (3) by adding to Section 2 thereto the following items:
- "fire chief" means the Fire Chief of the Corporation of the City of Brampton or such person as he may designate to carry out his duties under this by-law.
- "fire route" means any private roadway designated by the Fire Chief under the Fire Marshalls Act, R.S.O. 1990, F. 17.

(4) by adding to the specified columns of Schedule III thereto the following items:

Chadwick Road	The north limit of Carrie Crescent and the west limit of Lockwood Road
Herkes Drive	The east limit of Lockwood Road and the west limit of Drinkwater Road
Kitto Court	The south limit of Herkes Drive and the south limit of the road
Lockwood Road	The south limit of Queen Street West and the north limit of Drinkwater Road

(5) by adding to the specified columns of Schedule IV thereto the following items:

### **STOP SIGNS**

COLUMN 1 INTERSECTION	COLUMN 2 ", . FACING TRAFFIC ,
Kings Cross Road and Knightsbridge Road	Northbound on Kings Cross Road
Kings Cross Road and Knightsbridge Road	Eastbound on Knightsbridge Road
Kings Cross Road and Knightsbridge Road	Southbound on Kings Cross Road
Kings Cross Road and Knightsbridge Road	Westbound on Knightsbridge Road

2. / Subsections (1), (2), (4), and (5) of this by-law shall not come into force until approved by the council of The Regional Municipality of Peel.
