# BY-LAW

**Number** 77-96

To appoint Municipal By-law  
Enforcement Officers and to repeal  
By-law 54-96

WHEREAS paragraph 45 of section 207 of the Municipal Act (R.S.O. 1990, c. M.45, as amended) authorizes the appointment of such officers and servants as may be necessary for the purposes of the Municipal Corporation;

AND WHEREAS section 15 of the Police Services Act (R.S.O. 1990, c. P.15, as amended) authorizes the appointment of Municipal Law Enforcement Officers who shall be peace officers for the purposes of enforcing the by-laws of the Municipality;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:


2. By-law 54-96 is hereby repealed.
