1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by adding to Schedule X thereto the following item:

East Drive	60	Torbram Road and Bramalea Road	Anytime

(2) by deleting from Schedule XIV thereto the following item:

NO PARKING

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
East Service Road	Both	Hanna Street & Union Street	Anytime

(3) by adding to Schedule XIV thereto the following items:

NO PARKING

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
East Service Road	North	Hanna Street and a point 93 metres east of Hanna Street	6:00 am to 6:00 pm
East Service Road	North	A point 93 metres east of Hanna Street and the east limit of the road	Anytime
East Service Road	South	Hanna Street and the east limit of the road (including cul-de-sac)	Anytime

2. Subsection (1) of this by-law shall not come into force until approved by the council of the Regional Municipality of Peel
