The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by deleting from Schedule XXII thereto the following items:



Lanewood Street	The south limit of Peter Robertson Boulevard (westerly intersection) and the east limit of Woodsmere Court
Larkspur Road	The east limit of Fernforest Drive and the west limit of Bramalea Road
Springtown Trail	The west limit of Tigerlily Place (southerly intersection) and the south limit of Sandalwood Parkway
Summer Valley Drive	The north limit of the road and the north limit of Mayfield Road
Woodcreek Drive	The west limit of the road and the west limit of Summer Valley Drive.

2. Section (1), subsections (3) and (4) of this by-law shall not come into force until approved by the Regional Municipality of Peel.

Springtown Trail	The west limit of Tigerlily Place (southerly intersection) and the south limit of Sandalwood Parkway
Summer Valley Drive	The north limit of the road and the north limit of Mayfield Road
Woodcreek Drive	The west limit of the road and the west limit of Summer Valley Drive.

2. Section (1), subsections (3) and (4) of this by-law shall not come into force until approved by the Regional Municipality of Peel.
