# BY-LAW

Number 86-2004

To amend By-law 200-82 as amended, By-law 56-83 as amended,  
and By-law 139-84 as amended

---

The Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 200-82, as amended, is hereby further amended:
  - (1) by changing all section numbers and associated references that are over Section 49 throughout the entire By-law by adding the numerical number "3000" to the existing section numbers and associated references, that is, Sections 50 and 51 shall become Sections 3050 and 3051; their subsections 50.1, 50.2, 50.3, 51.1, 51.2, and 51.3 shall become 3050.1, 3050.2, 3050.3, 3051.1, 3051.2 and 3051.3 respectively; and reference to R4A-Section 50 and R4A-Section 51 shall become R4A-Section 3050 and R4A-Section 3051, and so on and so forth for the entire By-law, including the TABLE OF CONTENTS and references to Schedule C.
  - (2) by changing on Schedule A attached thereto, all references to section numbers by adding the numerical number of "3000" to the existing section number, that is, R4A-SECTION 50 and R4A-SECTION 51 shall become R4A-SECTION 3050 and R4A-SECTION 3051 respectively and so on and so forth for the entire Schedule A.
  - (3) by changing all references to section numbers on all Schedules C attached thereto by adding the numerical number of "3000" to the existing section number, that is, Schedule C-58 shall become Schedule C-3058 and Schedule C-59 shall become Schedule C-3059, and so on and so forth for all Schedules C.
2. By-law 56-83, as amended, is hereby further amended:
  - (1) by changing all section numbers and associated references that are over Section 400 throughout the entire By-law by adding the numerical number "1000" to the existing section numbers and associated references, that is, Sections 499 and 500 shall become Sections 1499 and 1500; their subsections of 499.1, 499.2, 500.1, 500.2, and 500.3 shall become 1499.1, 1499.2, 1500.1, 1500.2, and 1500.3 respectively; and references to A-Section 499 and RE2-Section 500 shall become A-Section 1499 and RE2-Section 1500, and so on and so forth for the entire By-law, including the TABLE OF CONTENTS and references to Schedule C.

- (2) by changing on Schedule A attached thereto, all references to section numbers by adding the numerical number of "1000" to the existing section number, that is, A-SECTION 499 and RE2-SECTION 500 shall become A-SECTION 1499 and RE2-SECTION 1500 respectively and so on and so forth for the entire Schedule A.
- (3) by changing all references to section numbers on all Schedules C attached thereto by adding the numerical number of "1000" to the existing section number, that is, Schedule C-Section 501 shall become Schedule C-Section 1501 and Schedule C-Section 502 shall become Schedule C-Section 1502, and so on and so forth for all Schedules C.

3. By-law 139-84, as amended, is hereby further amended:

- (1) by changing all section numbers and associated references that are over Section 500 throughout the entire By-law by adding the numerical number "2000" to the existing section numbers and associated references, that is, Sections 552 and 553.1 shall become Sections 2552 and 2553.1; their subsections 552.1, 552.2, 553.1, 553.1.1, 553.1.2, 553.1.3, and 553.2 shall become 2552.1, 2552.2, 2553.1, 2553.1.1, 2553.1.2, 2553.1.3, and 2553.2 respectively; and references to I2-Section 552 and HC1-Section 553 shall become I2-Section 2552 and HC1-Section 2553, and so on and so forth for the entire By-law, including the TABLE OF CONTENTS and references to Schedule C.
- (2) by changing on Schedule A attached thereto, all references to section numbers by adding the numerical number of "2000" to the existing section number, that is, I2-SECTION 552 and HC1-SECTION 553 shall become I2-SECTION 2552 and HC1-SECTION 2553 respectively and so on and so forth for the entire Schedule A.
- (3) by changing all references to section numbers on all Schedules C attached thereto by adding the numerical number of "2000" to the existing section number, that is, Schedule C Section 556 shall become Schedule C Section 2556 and Schedule C Section 558 will become Schedule C Section 2558, and so on and so forth for all Schedules C.



