To amend By-law 270-2004, as amended

The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-law 270-2004, as amended, is hereby further amended:

(1) by changing Schedule A thereto, the zoning designation of the lands as shown outlined on Schedule A to this by-law:

From:	To:
'Agricultural'	'Institutional – Section 1956 (I-1956)'

(2) by adding thereto the following section:

“1956 The lands designated I-1956 on Schedule A to this by-law:

1956.1 shall be subject to the following requirements and restrictions:

Minimum rear yard setback: 4 metres.”

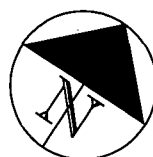

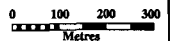

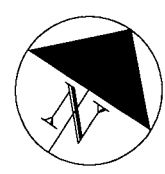


DECLARATION
