# **BY-LAW**

A by-law to amend Licensing By-law 1-2002, as amended (Electrical, Heating and Plumbing Contractors, Building Renovators, Taxi Cabs, Second Hand Goods (Clothing Drop Boxes), Adult Video Stores, Tow Trucks Vehicle Facility)

WHEREAS By-law 1-2002 as amended licenses Taxicabs for the purpose of health and safety and consumer protection; and

WHEREAS By-law 1-2002 as amended licenses Second Hand Goods Dealers for the purpose of consumer protection and nuisance control; and

WHEREAS By-law 1-2002 as amended licenses Electrical, Heating and Plumbing Contractors, and Building Renovators for the purpose of consumer protection; and

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

- 1. By-law 1-2002, the Licensing By-law, is hereby amended as follows:
  - (1) Schedule S-1 relating to Electrical, Heating and Plumbing Contractors is deleted and the attached Schedule I is substituted therefor;
  - (2) The attached Schedule II is added as Schedule S-12 relating to Building Renovators;
  - (3) Schedule M-5 relating to Taxi Cabs is amended by adding as section 17.1 the following provision:
    - (17.1) "Despite section 17, where a plate owner is unable to continue to qualify for a driver's licence for medical reasons for any period of time, which satisfactory medical documentation is provided, the requirement to hold a valid driver's licence shall be waived for that period".
  - (4) Schedule S-7 relating to Second Hand Goods Dealers is amended as follows:
    - (a) By adding to section 1, the definition, immediately following the words "shall include", the words "used clothing and household items";
    - (b) By adding to section 1 the following definition: "drop box" shall mean a box or container placed in public view for the express purpose of collecting

second hands goods";

- (c) By adding at the end of section 2, the words "unless drop boxes are utilized as a means of collecting such goods";
- (d) By adding as sections 10-12 the following:
  - 10. No person shall place or cause or permit to be placed at any location to which the public has access a drop box without first affixing thereto, in a clearly visible fashion, a validation sticker issued by the municipality, and no such sticker shall be issued for a drop box to be located within 500 metres of another drop box, whether required to be stickered or not.
  - 11. Where any drop box is placed or permitted to be placed in contravention of this by-law, the City may require the owner of the property or the licensee to remove such drop box.
  - 12. Where the City provides written notice to any property owner that placement of a drop box is in contravention of this by-law, and such drop box is not removed within a reasonable time, the City may remove the drop box at the expense of the property owner.

READ a FIRST, SECOND and THIRD time and PASSED in OPEN COUNCIL, this and August March, 2003.

#### Schedule II to By-law QD -2003

## Schedule S-12 to By-law 1-2002, as amended Relating to Building Renovators

- 1. Every person who conducts business or offers any services for which a licence is required under this Schedule under a name other than his personal name, shall register his business name with the Ministry of Consumer and Commercial Relations.
- 2. Every person licensed under this by-law as a building renovator shall observe or cause to be observed before commencing any work the following regulations:
  - before commencing any work, a building renovator shall enter into a written contract with the person for whom the work is to be performed to be signed by the building renovator and such person, and the contract shall set out the work to be performed, the start date, the estimated date of completion, the cost and the quality of materials to be used;
    - (ii) the building renovator shall complete the contract in as much detail as may be practical as to the quality and quantity of material and the number of hours of labour involved and the rate thereof and as to all other dimensions and measurements relating to the work to be done.

#### Schedule I to By-law 90 -2003

## Schedule S-1 to By-law 1-2002, as amended Relating to Electrical, Heating and Plumbing Contractors

- 1. Every electrical contractor, plumber, plumbing contractor, drain contractor, heating contractor, steam or hot water heating installer and warm air heating installer shall file with the License Issuer a copy of his Provincial trade certification.
- 2. Every person who conducts business or offers any services for which a licence is required under this Schedule under a name other than his personal name, shall register his business name with the Ministry of Consumer and Commercial Relations.
- 3. Every electrical contractor, plumber, plumbing contractor, drain contractor, heating contractor, steam or hot water heating installer and warm air heating installer shall provide to every person who requests a service from said contractor a schedule of rates, as well as a written estimate or written contract duly signed prior to the commencement of any work.
