BY-LAW

Number 93-88

To amend By-law 139-84 (part of Lot 14, Concession 2, E.H.S., in the geographic Township of Toronto)

The council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 139-84, as amended, is hereby further amended:

(1) by changing, on sheet 8 of Schedule A thereto, the zoning designation of the land shown outlined on Schedule A to this by-law from AGRICULTURAL PARKWAY BELT (AP) to INDUSTRIAL ONE - SECTION 604 (M1 - SECTION 604) and FLOODPLAIN (F).

(2) by adding thereto the following section:

"604 The lands designated M1-SECTION 604 on Schedule A to this by-law.

604.1 shall only be used for the purposes permitted by section 31.1.1 of this by-law.


604.2 shall be subject to the following requirements and restriction:

(1) a landscaped open space area, a minimum of 3 metres in width, shall be provided along the rear lot line.

604.3 shall also be subject to the requirements and restrictions relating to the M1 zone which are not in conflict with the ones set out in section 604.2."
