Number
To prevent the application of part lot control to part of Registered Plans 43M-1160
WHEREAS subsection 50(5) of the <u>Planning Act</u> , R.S.O. 1990 c.P.13, has imposed part lot control on all lands within registered plans within the City;
AND WHEREAS, pursuant to subsection 50(7) of the <u>Planning Act</u> , the council of a municipality may by by-law provide that part lot control does not apply to lands within such registered plans or parts thereof are designated in the by-law;
NOW THEREFORE the Council of The Corporation of the City of Brampton hereby ENACTS as follows
1. Subsection 5 of section 50 of the <u>Planning Act</u> , does not apply to the following lands:
City of Brampton, Regional Municipality of Peel, being composed of:
- the whole of Blocks 169, 170, 171, 172, 174, 175, 176, 177, 178, 179, 180, 181, 182, 183, 184, 185, 186, 187, 188, 189 and 190, on Registered Plan 43M-1160,
2. This by-law shall come into force upon approval thereof by The Regional Municipality of Peel.
