STOP SIGNS AND THROUGH HIGHWAYS

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by deleting from Schedule X thereto the following item:

RATE OF SPEED

COLUMN 1 HIGHWAY	COLUMN 2 RATE OF SPEED	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Creditview Road	80	Mayfield Road and a point 350 metres north of Queen Street West	Anytime

(2) by adding to Schedule X thereto the following item:


