BY-LAW

Number 98-84
To constitute and appoint a
committee of adjustment, to
prescribe a tariff of fees for
minor variance applications, and
to provide for compensation to
members of the Committee of
Adjustment

WHEREAS, pursuant to section 43(1) of the Planning Act, 1983 (S.O. 1983, c. 82, as amended) (hereinafter referred to as the "Act"), the council of a municipality may by by-law constitute and appoint a committee of adjustment for the municipality;

AND WHEREAS, pursuant to section 43(9) of the Act, the members of the committee shall be paid such compensation as the council may provide;

AND WHEREAS, pursuant to section 68(1) of the Act, the council may by by-law prescribe a tariff of fees for the processing of applications made to the committee of adjustment;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:


1. A committee of adjustment for the City of Brampton, to be called the Committee of Adjustment, is hereby constituted.
2. The persons whose names are set out in Schedule A to this by-law are hereby appointed to be members of the Committee of Adjustment.

3. Compensation shall be paid to the members of the Committee of Adjustment in accordance with the provisions of Schedule C to this by-law.
4. A fee shall be charged for the processing of each application to the Committee of Adjustment, in accordance with the tariff of fees set out in Schedule B to this by-law.
5. By-law 219-83 is hereby repealed.
