To amend amended, Concession Area)	Part	of	Lot	5,

The council of The Corporation of the City of Brampton ENACTS as follows:

- 1. By-law 200-82, as amended, is hereby further amended:
 - (1) by changing on Sheet 23, of Schedule A thereto the zoning designation of the lands shown outlined on Schedule A to this by-law from GENERAL COMMERCIAL (GC) to GENERAL COMMERCIAL SECTION 276 (GC SECTION 276), and from OPEN SPACE (OS) to OPEN SPACE SECTION 277 (OS SECTION 277), such lands being part of Lot 5, Concession 1, W.H.S.
 - (2) by adding thereto the following sections:
 - "276. The lands designated GC SECTION 276 on Sheet 23 of Schedule A to this by-law:
 - 276.1 shall only be used for the purposes permitted in the GC Zone.
 - 276.2 shall be subject to the following requirements and restrictions:
 - (a) Minimum Side Yard Width:
 - 0 metres.
 - 276.3 shall also be subject to the requirements and restrictions relating to the GC Zone, and all the general provisions of this by-law, which are not in conflict with those set out in section 276.2.


- 277. The lands designated OS SECTION 277 on Sheet 23 of Schedule A to this by-law:
- 277.1 shall only be used for the following purposes:
 - (a) an administrative office of any public authority;
 - (b) an underground parking garage;
 - (c) the purposes permitted in the OS Zone; and,
 - (d) purposes accessory to the other permitted purposes."
- 277.2 shall be subject to the following requirements and restrictions:
 - (a) Minimum Front and Rear Yard Depth, and Interior Side Yard Width:
 - 0 metres.
- 277.3 shall also be subject to the requirements and restrictions relating to the OS Zone, and all the general provisions of this by-law, which are not in conflict with those set out in section 277.2.


