To appoint officers to
enforce By-law 206-79
(regulating parking on
private and municipal
property)

WHEREAS paragraph 45 of section 210 of the Municipal Act (R.S.O. 1980, c. 302, as amended) provides that a municipality may pass by-laws for appointing such officers and servants as may be necessary for carrying into effect the provisions of any by-law of the council, and for prescribing their duties;

AND WHEREAS it is necessary to appoint additional officers to enforce the provisions of By-law 206-79 (which regulates parking on private and municipal property) in respect of certain private properties;

NOW THEREFORE the council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

1. The individuals named in column 1 of Schedule A to this by-law are hereby appointed as by-law enforcement officers for the purposes of By-law 206-79, but only in respect of the properties named and identified in column 2 of Schedule A to this by-law.

2. In enforcing By-law 206-79, a by-law enforcement officer appointed under this by-law may only take the actions authorized by section 4 of By-law 206-79.
