



THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 104-83
To change certain street names
(Third Line West, Upper Churchville
Road and Travelled Connecting Road)

WHEREAS paragraph 105 of section 210 of the Municipal Act (R.S.O. 1980, chapter 302, as amended) permits the council of a local municipality to pass by-laws changing the names of public highways;

AND WHEREAS the Council of The Corporation of the City of Brampton deems it expedient to change the names of certain public highways;

AND WHEREAS notice of the intention to pass this by-law has been published once a week for four successive weeks in the Daily Times, a newspaper having general circulation in the City of Brampton;

AND WHEREAS the Council has heard all persons who claimed that they would be adversely affected by this by-law and who applied to be heard;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

1. The name of the street known as "Third Line West", being the road allowance between Concessions 3 and 4, West of Hurontario Street, from the northerly limit of Steeles Avenue to the southerly limit of Number 17 Sideroad, is changed to and is to be known as part of "Creditview Road".

2. The road comprising part of Lots 1 and 2, Concession 3, West of Hurontario Street, referred to as the "Forced Road" in an instrument registered in the Land Registry Office for the Registry Division of Peel (No. 43) as number 11560, and shown in part on a sketch attached to an instrument registered in said Land Registry Office as number 200600V.S. as "Upper Churchville Road" and "Travelled Connecting Road", which road runs from the northerly limit of Steeles Avenue to a point in the northeasterly limit of the road now known as Third Line West (and to be known as Creditview Road), to be changed to and to be known as "Churchville Road".
3. The street name changes affected by sections 1 and 2 to this by-law are shown on the map attached as Schedule "A" hereto.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 11th day of April , 1983.

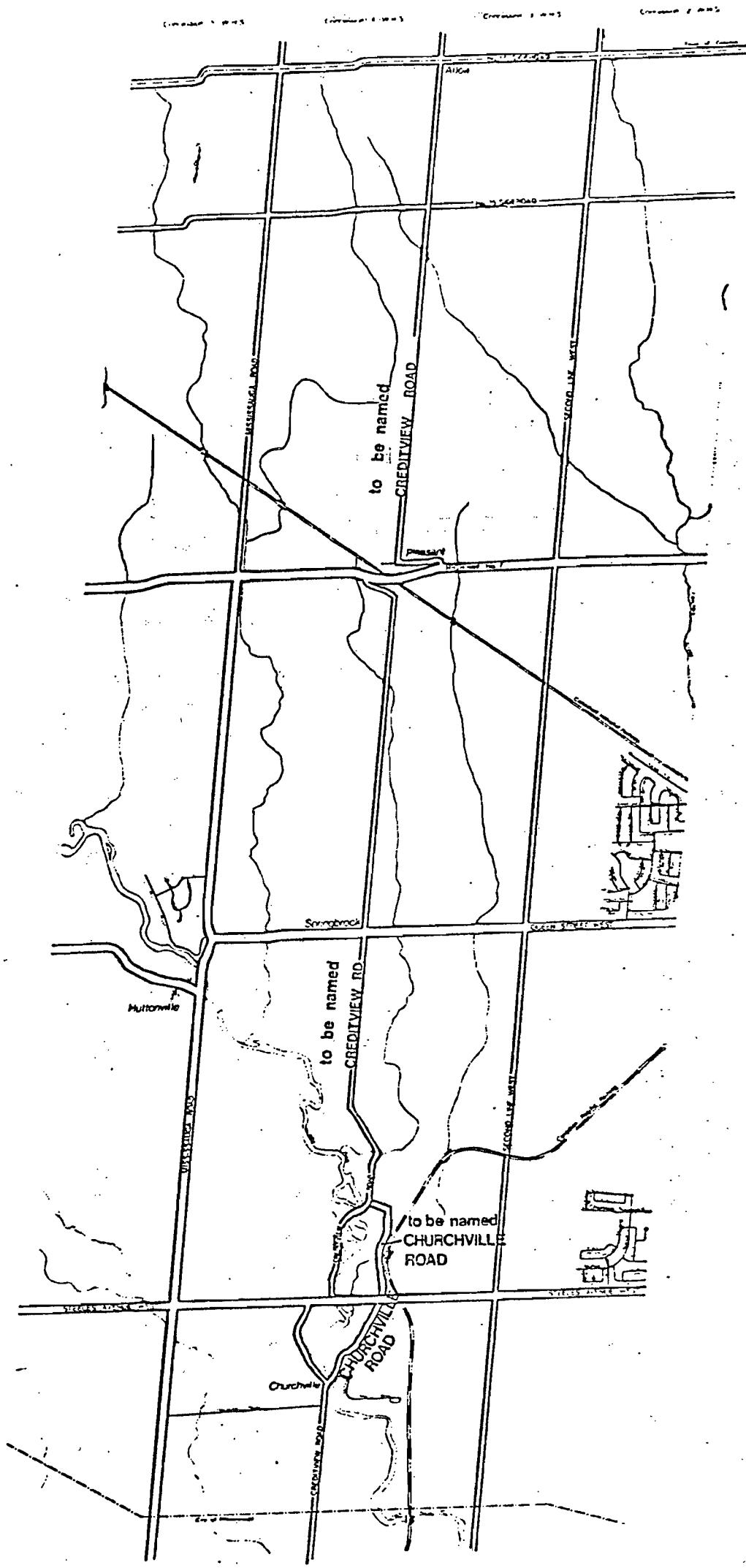

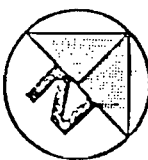
Schedule "A"
