# **BY-LAW**

Number /11-2012

To establish certain lands as part of the public highway system (Bramalea Road, Countryside Drive and Goreway Drive)

**WHEREAS** it is deemed expedient to establish certain lands as part of the public highway system.

**NOW THEREFORE** the Council of The Corporation of the City of Brampton **ENACTS AS FOLLOWS**:

## **Bramalea Road**

- The lands acquired by The Corporation of the City of Brampton and described as Part of Lot 17, Concession 4 EHS, former township of Chinguacousy, designated as Part 4 on Plan 43R-30958 is hereby established as part of the public highway system to be part of Bramalea Road.
- 2. The lands acquired by The Corporation of the City of Brampton and described as Part of Lot 17, Concession 4 EHS, former township of Chinguacousy, designated as Part 11 on Plan 43R-32009 is hereby established as part of the public highway system to be part of Bramalea Road.

#### **Countryside Drive**

- 3. The lands acquired by The Corporation of the City of Brampton and described as Part of Lot 15, Concession 7, Northern Division, former township of Toronto Gore, designated as Part 1 on Plan 43R-34503 is hereby established as part of the public highway system to be part of Countryside Drive.
- 4. The lands acquired by The Corporation of the City of Brampton and described as Part of Block 5, Plan M312, former township of Toronto Gore designated as Part 18 on Plan 43R-33312 is hereby established as part of the public highway system to be part of Countryside Drive.

## **Goreway Drive**

- 5. The lands acquired by The Corporation of the City of Brampton and described as Part of Lot 15, Concession 7, Northern Division, former township of Toronto Gore, designated as Part 2 on Plan 43R-34503 is hereby established as part of the public highway system to be part of Goreway Drive.
- 6. The lands acquired by The Corporation of the City of Brampton and described as Part of Block 135, Plan 43M-1632, former township of Toronto Gore, designated as Part 20 on Plan 43R-33312 is hereby established as part of the public highway system to be part of Goreway Drive.
- 7. The lands acquired by The Corporation of the City of Brampton and described as Part of Block 136, Plan 43M-1632, former township of Toronto Gore, designated as Part 19 on Plan 43R-33312 is hereby established as part of the public highway system to be part of Goreway Drive.
