1. The Mayor and the Clerk are hereby authorized to execute an agreement dated 1981 05 11 between James L. Betts Enterprizes Limited and The Corporation of the City of Brampton relating to the rental of roller skates, and all other documents approved by the City Solicitor required to implement the provisions of this agreement.

THIS LEASE AGREEMENT dated the 1st day of May 1981

BETWEEN:

1.

JAMES L. BETTS ENTERPRIZES LIMITED a corporation incorporated under the laws of the Province of Ontario,

hereinafter called the LESSOR OF THE FIRST PART

- and -

THE CORPORATION OF THE CITY OF BRAMPTON

hereinafter called the LESSEE OF THE SECOND PART

- 1. In consideration of the rents, covenants and agreements hereinafter contained the Lessor does hereby lease to the Lessee 200 (Two Hundred) pairs of Roller Skates and 4 Portable Racks, which the Lessor warrants will be in first class condition at the date of delivery; the Lessee has the right to refuse acceptance of any equipment which it does not deem to be in first class condition at delivery.
- 2. The lease shall be for a term of 4 months commencing on the 4th day of the month of May and shall end on the 6th day of the month of September.
- 3. The rent under this lease shall be at the rate of \$4.50 per pair per month, plus Provincial Sales Tax if applicable, payable upon the last day of every month during the said term, and the first payment to be made on the 31st day of May.
- 4. The Lessee agrees that the leased equipment shall be located at various premises of the Lessee, being

and other City of Brampton facilities if required and used only at these premises.

- 5. The Lessee will assume the sole responsibility for the condition, operation and maintenance of the leased equipment during the term of this lease; the Lessor shall supply parts for the Lessee at no charge to the Lessee, to do the repairs and maintenance of the leased equipment. The Lessor shall retain the right to examine the condition of the equipment at any time during the term of the lease and if the equipment is being misused or abused, the Lessor shall give written notice to the Lessee to cancel the contract twenty days hence and to remove the equipment from the said premises at that time, unless there is a mutually satisfactory alternative.
- 6. The Lessee agrees with the Lessor to replace any of the leased equipment, which is lost, stolen, destroyed by fire or damaged in any manner, reasonable wear and tear excepted during the period of the lease, with equipment of like kind, age and quality, or the cash equivalent.
- 7. The Lessee agrees with the Lessor that the Lessee will at all times protect, indemnify and save harmless the Lessor or its assigns from and against any and all loss arising out

of claims against the Lessor for personal injury (including death) or damage to property caused by or arising out of the condition of the leased equipment, or by the use or misuse thereof by the Lessee, its servants, agents, employees, licensees, invitees or the third persons.

8. The Lessee covenants and agrees to maintain at his own expense and in full force and effect at all times a policy of general liability insurance naming the Lessor as a party insured, insuring the Lessor against the risks set out in paragraph 7 of this agreement.

Witness the corporate seals of the corporate parties duly attested by the hands of their proper signing officers in that behalf.


