To amend By-law 861, of the former Township of Chinguacousy, now in the City of Brampton. (Part of Lot 9, Concession 3, E.H.S.

The Council of The Corporation of the City of Brampton ENACTS as follows:

- Schedule A of By-law 861, as amended, being the Restricted Area By-law of the former Township of Chinguacousy, is hereby further amended by changing the zoning designations of the land shown outlined on Schedule A attached to this by-law from RESIDENTIAL 5D SECTION 231 (R5D-SECTION 231), RESIDENTIAL 5D SECTION 232 (R5D-SECTION 232), RESIDENTIAL MULTIPLE RM1C SECTION 234 (RM1C-SECTION 234) and RESIDENTIAL MULTIPLE RM1C SECTION 235 (RM1C-SECTION 235) to RESIDENTIAL R7 (R7).
- 2. By-law 861, as amended, and as specifically amended by By-law 175-79 and 98-82, is hereby further amended by deleting from Schedule A thereto Sheet 4 of the maps added to the said Schedule A by By-law 98-82, and substituting therefor Schedule B attached to this by-law.




Zone Boundary
