To amend Interim Control By-Law 35-2013, An Interim Control By-Law applicable to Part of the Area Subject to By-Law 270-2004, as amended, and known municipally as 45 Barr Crescent.


The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-Law 35-2013, as amended, is hereby amended as follows:
 - 1.1 Section 1 is amended by adding after the words "Except as provided for in Section 1.1, Section 1.2, Section 1.3, and Section 1.4", the following:
"Section 1.5"
 - 1.2 The following is added as Section 1.5:
"1.5 On lands described as Concession 2 EHS, Part of Lot 8, and referenced as the "Lands Subject to Specific Exemption From Interim Control By-Law 35-2013, as amended by By-Law 119-2013" and as shown on Schedule A to this by-law as 45 Barr Crescent, there shall be permitted an addition to the principal building resulting in a total gross floor area of the principal building not exceeding 280 square metres."
2. By-Law 35-2013 is hereby further amended by adding thereto, as Schedule D, Schedule A to this by-law.

READ a FIRST, SECOND AND THIRD TIME, and PASSED, in OPEN COUNCIL, this 8TH day of MAY 2013.


