
Being a By-law to Amend Restricted Area By-law Number 861 as amended by By-law Number 877 as amended of the former Township of Chinguacousy.


The Council of the City of Brampton ENACTS as follows:

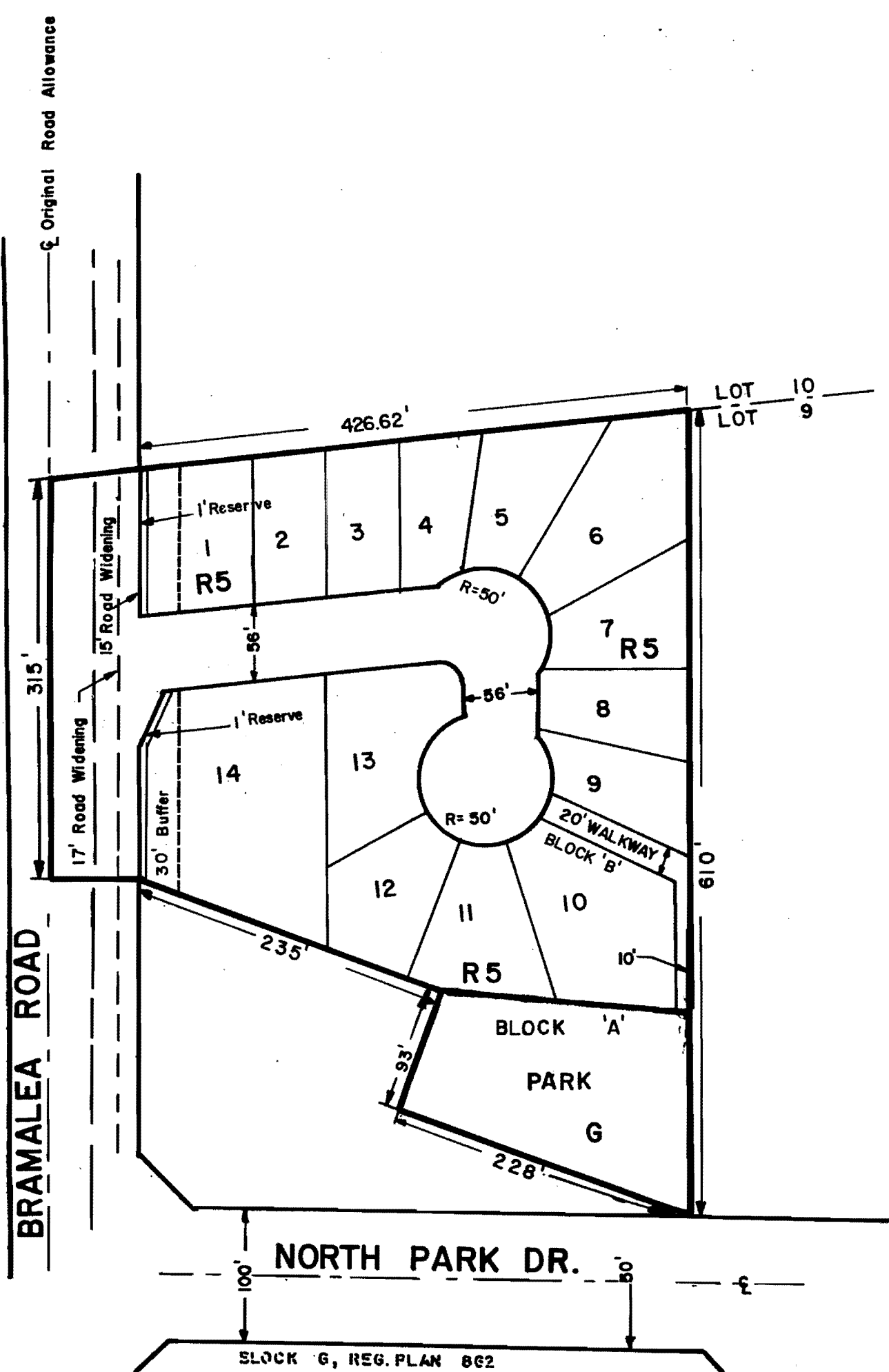
1. That By-law Number 861 as amended by By-law Number 877 as amended of the former Township of Chinguacousy be, and the same are, hereby amended to rezone the lands described in Schedule 'A' hereto attached to be used only for the following purposes:
 - (a) That part of the lands shown on Schedule 'A' as R5 (Residential Single Family Class 5) may be used for single family residential purposes only subject to the provisions of Section 14(C) of said By-law Number 861 as amended.
 - (b) And that part of the lands shown on Schedule 'A' as G (Conservation and Greenbelt) may be used for greenbelt purposes only subject to the provisions of Section 21 of said By-law Number 861 as amended.
2. That Schedule 'A', the zoning map forming part of By-law Number 861 as amended by By-law Number 877 as amended is hereby amended by the addition to Schedule 'A' of said By-law Number 861 of the lands described on Schedule 'A' hereto attached.
3. That all the provisions of a Residential Single Family Class 5 (R5) Zone shall apply to the lands hereby rezoned with the exception that the minimum lot area shall be five thousand (5,000) square feet.
4. This By-law shall not come into force and effect unless and until approved by the Ontario Municipal Board.

READ A FIRST, SECOND AND THIRD TIME AND PASSED IN OPEN COUNCIL

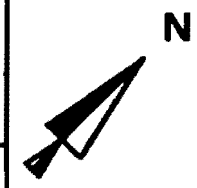

SCHEDULE 'A'

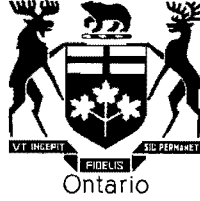

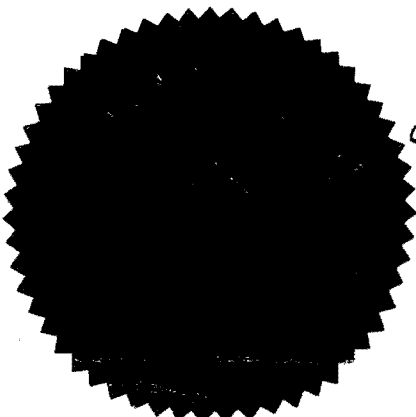
