The council of The Corporation of the City of Brampton
ENACTS as follows:

1. By-law 56-83, as amended, is hereby further amended:
 - (1) by changing, on Sheet 19 of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this by-law from INDUSTRIAL FOUR - SECTION 566 (M4 - SECTION 566) to INDUSTRIAL THREE - SECTION 565 (M3 - SECTION 565) being part of Lot 3, Concession 8, Northern Division, in the geographic Township of Toronto Gore.

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL,
this 16th day of July 1990.

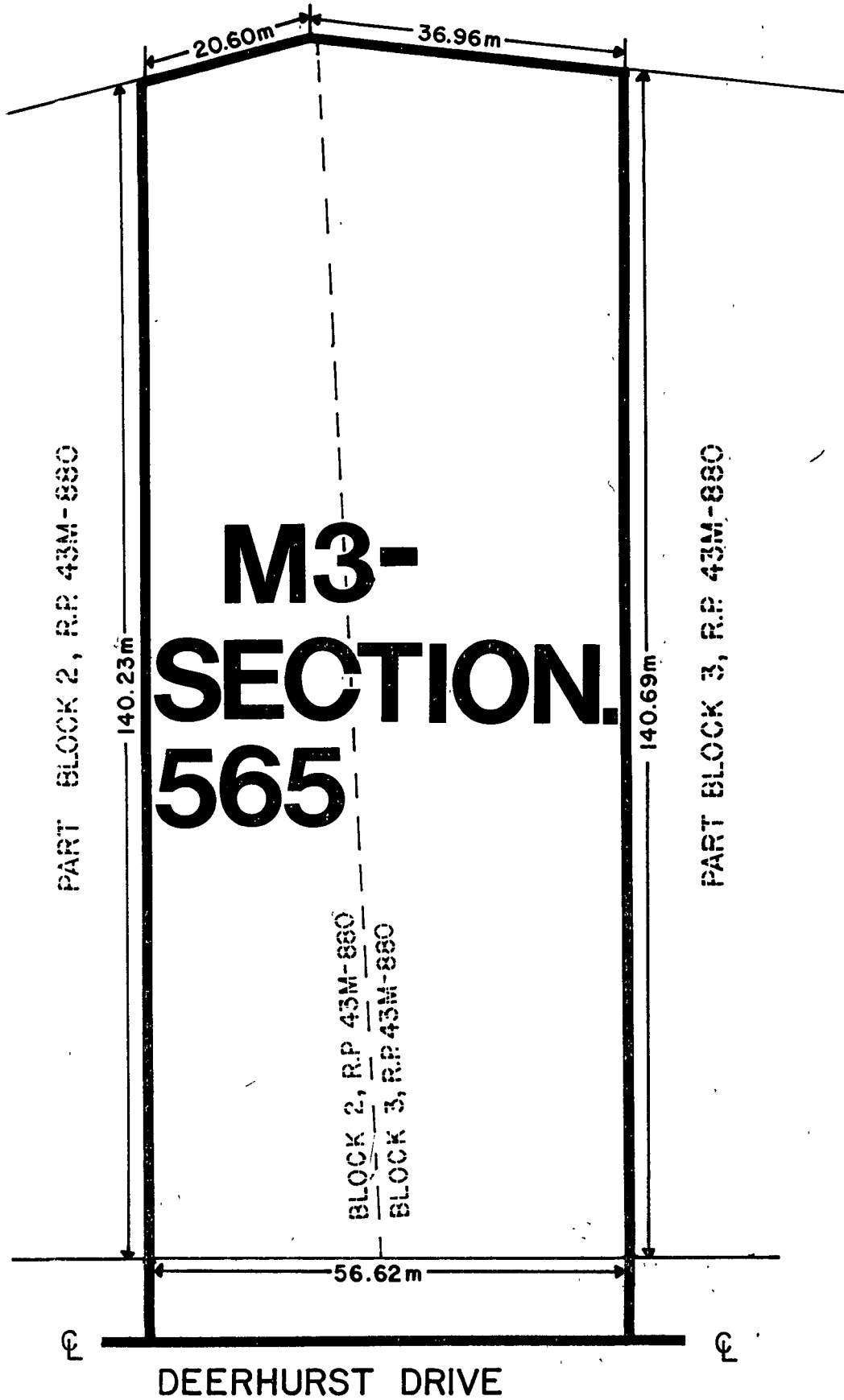
