# BY-LAW

Number 122-94

To amend By-law 151-88, as amended

The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-law 151-88, as amended, is hereby further amended:
  - (1) by changing on Sheet 25-D of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this by-law from AGRICULTURAL (A) to RESIDENTIAL SINGLE FAMILY D - SECTION 674 (R1D - SECTION 674), and OPEN SPACE (OS).
  - (2) by deleting therefrom, section 455.2 (9) and renumbering section 455.2(10) to 455.2(9).

(NOTE: Section 674 was created by By-law 94-93)

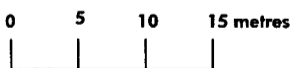
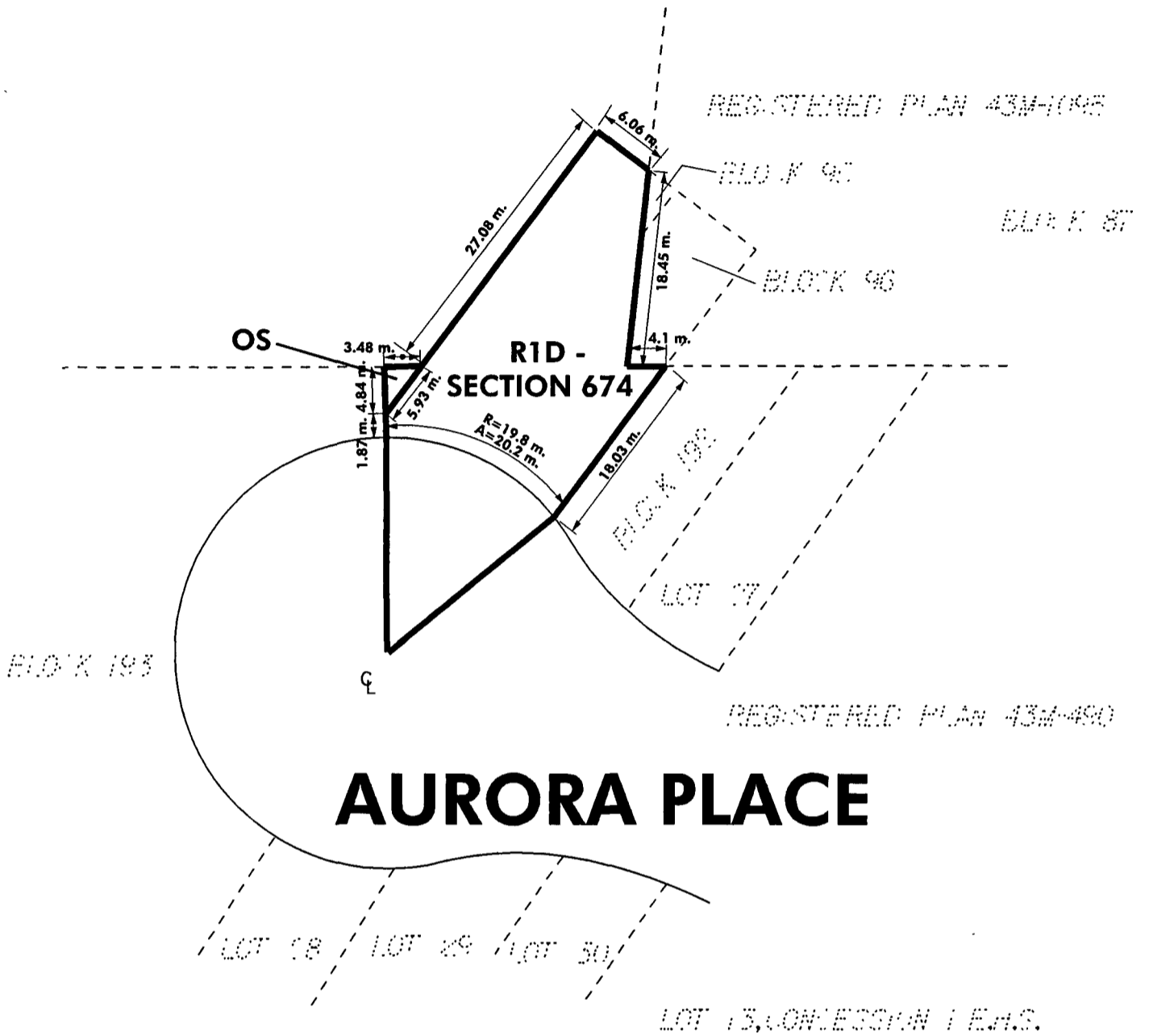


