

THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW NUMBER 124-74

Being a By-law to amend Restricted Area By-law Number 861 as amended by By-law Number 877, of the former Township of Chinguacousy, to rezone lands in Block "C" Registered Plan Number 636 from Industrial "M-1" to Industrial "M5-S".

WHEREAS Official Plan Amendment Number 64 of the former Township of Chinguacousy Planning Area permits Warehousing, Manufacturing, Business and Professional Offices in Block "C" Registered Plan 636.

The Council of the Corporation of the City of Brampton therefore enacts as follows:

- 1) That By-law Number 861 as amended by By-law Number 877 and as further amended by By-law Number 21-73 be further amended by changing from Industrial "M-1" to Industrial "M5-S" designating those lands described in Schedule 'A' attached hereto.
- 2) Schedule 'A' forms part of this By-law.
- 3) This By-law shall come into force on the date of passing thereof by Council subject to approval by the Ontario Municipal Board.




