# BY-LAW

Number 124-90

To establish certain lands  
as a public highway  
(BRAMALEA ROAD)

WHEREAS it is deemed expedient to establish certain lands as part of the public highway system:

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. The lands acquired by The Corporation of the City of Brampton and described in Schedule A to this by-law are hereby established as part of the public highway system of the City of Brampton.

READ a FIRST, SECOND, and THIRD TIME, and PASSED in open Council this 16th day of JULY, 1990.

SCHEDULE A TO BY-LAW NO. 124-90

Part of LOT 14, CONCESSION 5, EAST OF HURONTARIO STREET (formerly in the Township of Chinguacousy, County of Peel) now in the City of Brampton, Regional Municipality of Peel, and containing by admeasurement 0.784 acres be the same more or less the limits of which said parcel may be more particularly described as follows:

PREMISING that the bearings herein are referred to the northwesterly limit of the road allowance between Lots 5 and 6, Concession 5, East of Hurontario Street (the King's Highway Number 7) assumed to be North 39 degrees 30 minutes 30 seconds East in accordance with Department of Highways Plan P-1899-15;

COMMENCING at a survey monument in the Westerly angle of Lot 14:

THENCE South 44 degrees 27 minutes 40 seconds East along the Southwesterly limit of Lot 14 a distance of 2,008.57 feet to a survey monument in the most Southerly angle of Lot 14;

THENCE North 39 minutes 05 minutes 40 seconds East along the Southeasterly limit of Lot 14 a distance of 17.11 feet to a point;

THENCE North 44 degrees 27 minutes 40 seconds West along a line drawn parallel to the Southwesterly limit of Lot 14 and distance 17.00 feet measured perpendicularly therefrom and at right angles thereto 2,002.73 feet to a survey monument;

THENCE North 44 degrees 31 minutes 10 seconds West 5.96 feet to a point in the Northwesterly limit of Lot 14;

THENCE South 38 degrees 43 minutes 00 seconds West along the last mentioned Northwesterly limit 17.12 feet to a survey monument being the point of commencement.
