Number 126-94

To change the name of Bramtrail Court

WHEREAS by By-law 289-89 registered as Instrument No. LT1079341, the Council of The Corporation of the City of Brampton established the lands described in Schedule A to this by-law as part of the public highway system named Bramtrail Court.

AND WHEREAS the Council of The Corporation of the City Brampton deems it expedient to change the name of Bramtrail Court;

AND WHEREAS notice of the intention to pass this bylaw has been published one a week for four successive weeks in The Brampton Guardian, a newspaper having general circulation in the City of Brampton;

AND WHEREAS the Council has heard all persons who claimed that they would be adversely affected by this by-law and who applied to be heard;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

- The name of the street known as "Bramtrail Court" as described in Schedule A to this by-law is "Precisioncraft Court".
- The affidavit of Leonard J. Mikulich attached as Schedule B hereto shall form part of this by-law.

READ A FIRST, SECOND AND THIRD TIME, and passed in open Council this 27th day of June, 1994.

TAKE NOTICE that the Council of The Corporation of the City of Brampton proposes to enact a by-law pursuant to Paragraph 111 of Section 210 of the Municipal Act, changing the name of the public highway known as "Bramtrail Court" and described below to "Precisioncraft Court".

Bramtrail Court consists of the part of Block 1, Registered Plan 43M-873 designated as Part 1 on Reference Plan 43R-17302 and was established as a public highway by By-law 289-89 registered as Instrument No. LT1079341.

A print of 43R-17302 showing the location of Bramtrail Court may be inspected at the Office of the Clerk during normal business hours. The proposed by-law will come before Council for consideration at its regular meeting in the Council Chambers in the Municipal Offices, 2 Wellington Street West, Brampton on the 27th day of June, 1994 at the hour of 7:00 in the afternoon, and at that time, the Council will hear any person who claims that he will be adversely affected by the by-law and who applies to be heard.
