WHEREAS it is deemed necessary to enter into and execute a Cessation of Charge;


NOW THEREFORE the Council of the Corporation of the City of Brampton hereby ENACTS as follows:


- (1) THAT the City of Brampton enter into and execute a Cessation of Charge in the form attached hereto as Schedule "A", with the following:
