Being a By-law to Amend By-law Number 5500 as amended of the Former Town of Mississauga

The Council of the Corporation of the City of Brampton ENACTS as follows:

By-law Number 5500 as amended is hereby amended by adding thereto the following section 759


- Section 759
1. Map Number 45 contained in Schedule 'B' attached to By-law Number 5500 as amended of the former Town of Mississauga is hereby amended by changing thereon from 'A' to 'C2' for the property outlined as shown on the Schedule 'A' of this By-law hereto attached.
 2. Notwithstanding the 'C2' zone designation, the land zoned 'C2' in this By-law shall only be used for banks; restaurants; take-out foods; undertaking establishments' clubs whether fraternal or operated for profit; business, professional and administrative offices; exhibition and conference halls; shops for repair or manufacture of small goods and wares; shoe shops and repair; dry-cleaning; laundry and dyeing establishments; barber shop; beauty parlor; variety shop; printing establishment; and any operations of the Municipal Regional, Provincial and Federal Governments.
 3. Schedule 'A' hereto attached form part of this By-law.

4. This By-law shall not come into force and effect until and unless approved by Ontario Municipal Board.






CITY OF BRAMPTON BY-LAW No. 136-77


