BY-LAW

Number 137-77

Being a By-law to Amend By-law Number 5500 as amended of the former Town of Mississauga.

The Council of the Corporation of the City of Brampton ENACTS as follows:


By-law Number 5500 as amended is hereby amended by adding thereto the following Section 758:

- Section 758
1. Map Number 45 contained in Schedule 'B' attached to Bylaw Number 5500 as amended of the former Town of Mississauga is hereby amended by changing thereon from 'A', 'M1', 'M2', and 'M5' to 'M1', 'G' and 'AC4' for the property outlined as shown on the Schedule 'A' of this By-law hereto attached.
 2. Notwithstanding the industrial zone, Section 109 (c) of By-law Number 5500 as amended shall not apply to the land zoned by the By-law. In addition to the primary uses permitted in Section 110, only those commercial uses directly incidental to the principal industrial use shall be permitted provided that such use shall not exceed ten percent (10%) of the primary use gross floor area.
 3. Notwithstanding the 'M1' zone, no outside storage shall be permitted in the area as shown on Schedule 'A' of this By-law hereto attached.
 4. Notwithstanding the 'AC4' zone, the land zoned 'AC4' of this By-law shall only be used for automobile service station and car wash only.
 5. Schedule 'A' hereto attached form part of this By-law.

6. This By-law shall not come into force and effect until and unless approved by Ontario Municipal Board.



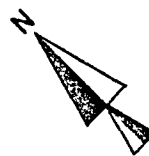
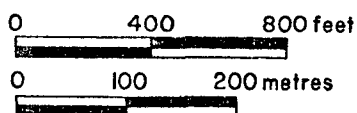


CITY OF BRAMPTON BY-LAW No. 137-77

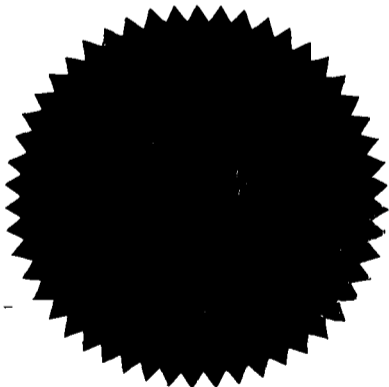
