To accept and assume as public
highways certain lands shown on

Registered Plan M-287

WHEREAS it is deemed expedient to accept and assume certain streets and lands shown on Registered Plan M-287 as public highways;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

1. The lands dedicated as public highways and described in Schedule A to this by-law are hereby accepted and assumed as part of the public highway system of the City of Brampton.
2. The lands acquired by The Corporation of the City of Brampton, and described in Schedule B. to this by-law, are hereby established as part of the public highway system of the City of Brampton.

Schedule A

The land situated in the City of Brampton, in the Regional Municipality of Peel, and being,

FIRSTLY: the whole of Leone Lane, as shown on a plan of subdivision registered in the Land Registry Office for the Land Titles Division of Peel (No. 43) as number M-287;

SECONDLY: the whole of Luana Court, as shown on the said Registered Plan M-287;

THIRDLY: the whole of Evergreen Avenue as shown on said Registered Plan M-287; and

FOURTHLY: the whole of Block A (street widening) as shown on said Registered Plan M-287; (the part of said Block A abutting the existing travelled road (Castlemore Road) to be assumed as part of Castlemore Road, and the part of Block A abutting Goreway Drive to be assumed as part of Goreway Drive)

Schedule B

The land situated in the City of Brampton, in the Regional Municipality of Peel, and being,

FIRSTLY: the whole of Block H according to a plan of subdivision registered in the Land Registry Office for the Land Titles Division of Peel (No. 43) as number M-287;
(to be part of Leone Lane)

SECONDLY: the whole of Blocks I and J according to said Registered Plan M-287;
(to be part of Evergreen Avenue).
