# BY-LAW

Number 140-2004

To accept and assume works in  
Registered Plans 43M-1299 and 43M-1300

**WHEREAS** the Council of The Corporation of the City of Brampton has, by resolution, decided that all works constructed and installed in accordance with the subdivision agreement for Registered Plans 43M-1299 and 43M-1300 be accepted and assumed;

**AND WHEREAS** Council has authorized the City Treasurer to retain \$3,000.00 in the Master Letter of Credit held by the City until the expiration of the maintenance period of the acoustic fencing in connection with the registered plans;

**AND WHEREAS** Council has authorized the City Treasurer to retain \$5,000.00 in the Master Letter of Credit held by the City for outstanding valley and streetscape works in connection with Registered Plan 43M-1299;

**AND WHEREAS** Council has authorized the City Treasurer to retain \$20,000.00 in the Master Letter of Credit held by the City for outstanding valley and streetscape works in connection with Registered Plan 43M-1300;

**AND WHEREAS** it is deemed expedient to accept and assume the streets and street widenings on Registered Plans 43M-1299 and 43M-1300 as part of the public highway system.

**NOW THEREFORE** the Council of The Corporation of the City of Brampton hereby **ENACTS** as follows:

1. All of the works constructed and installed in accordance with the subdivision agreement for Registered Plans 43M-1299 and 43M-1300 are hereby accepted and assumed.
2. The lands described in Schedule A to this by-law are hereby accepted and assumed as part of the public highway system of the City of Brampton.
