The Mayor and Clerk are hereby authorized to execute a licence amending agreement with Canadian National Railway Company, together with all other documents that, in the opinion of the City Solicitor are necessary to give effect to the terms of the licence amending agreement, in a form approved by the City Solicitor, for the purpose of Canadian National Railway Company performing certain approved works that will increase the efficiency of the Brampton Intermodal Terminal.

## LICENCE AMENDING AGREEMENT

made this 19<sup>th</sup> day of June, 2000.

### BETWEEN:

#### THE CORPORATION OF THE CITY OF BRAMPTON

hereinafter called the City  
OF THE FIRST PART

- and -

#### CANADIAN NATIONAL RAILWAY COMPANY

hereinafter called the Licensee  
OF THE SECOND PART

**WHEREAS** the City and Licensee entered into a licence agreement ("Licence") dated the 1<sup>st</sup> day of January, 1994, respecting certain City lands described as parts of Lots 2 and 3, Concession 7 Northern Division designated as Part 1 on Plan 43R-8597, in the City of Brampton, Regional Municipality of Peel, for the purpose of the Licensee constructing, using, and maintaining two (2) culverts;

**AND WHEREAS** the City and Licensee desire to amend the Licence in order to document certain works proposed by the Licensee;

**NOW THEREFORE**, in consideration of the sum of TWO (\$2.00) DOLLARS payable by each party to the other, receipt of which is hereby acknowledged, the City and Licensee agree as follows:

The Licence is hereby amended by inserting after Clause 1 the following:

"1A. At its own risk and expense, to install a communications cable across the drainage channel south of Intermodal Drive and to widen the crossing over the drainage channel north of Intermodal Drive, according to the drawings entitled *Entrance Expansion Electrical, Electrical Layout and Culvert Extension, General Arrangement*, as approved by the City and the Toronto Region Conservation Authority."
