BY-LAW

Number 143-2008

To amend Traffic By-law 93-93, By amending Schedules relating to THROUGH HIGHWAYS, STOP SIGNS, RATE OF SPEED

The Council of The Corporation of the City of Brampton hereby ENACTS as follows:

- 1. By-law 93-93, as amended, is hereby further amended as follows:
 - (1) by adding to Schedule III thereto the following items:

THROUGH HIGHWAYS

COLUMN 1	COLUMN 2
HIGHWAY	BETWEEN
Fernforest Drive	The north limit of Octillo Boulevard/Dewside Drive and the south limit of Father Tobin Road
Fernforest Drive	The north limit of Father Tobin Road and the north limit of Abitibi Lake Drive
Van Kirk Drive	The north limit of Accent Circle/ Delphinium Way and the north limit of Bramtrail Gate
Van Kirk Drive	The south limit of Bramtrail Gate and the north limit of Wanless Drive

(2) by deleting from Schedule III thereto the following items:

THROUGH HIGHWAYS

COLUMN 1	COLUMN 2
HIGHWAY	BETWEEN
Fernforest Drive	The north limit of Octillo Boulevard/Dewside Drive and the north limit of the roadway
Van Kirk Drive	The north limit of Perkins Drive and the north limit of Wanless Drive

(3) by adding to Schedule IV thereto the following items:

STOP SIGNS

Charolais Boulevard and James Potter Road	Eastbound on Charolais Boulevard
Charolais Boulevard and James Potter Road	Northbound on James Potter Road

Bramtrail Gate and Van Kirk Drive	Westbound on Bramtrail Gate
Bramtrail Gate and Van Kirk Drive	Northbound on Van Kirk Drive
Bramtrail Gate and Van Kirk Drive	Southbound on Van Kirk Drive

(4) by adding to Schedule X thereto the following items:
