

THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 145-2003.

To authorize the transfer of reserves to The Regional Municipality of Peel

WHEREAS the Lands described in Schedule "A" hereto (the "Lands") were conveyed to the City as reserves abutting 2nd Line West known as Chinguacousy Road;

AND WHEREAS responsibility for the portion of Chinguacousy Road abutting the Lands has been assumed by The Regional Municipality of Peel by Region By-law 95-79 passed February 23, 1995, as amended;

AND WHEREAS it is therefore deemed expedient in the interest of The Corporation of the City of Brampton that the Lands be transferred to The Regional Municipality of Peel;

AND WHEREAS the Lands were originally conveyed to the City for nominal consideration;

AND WHEREAS the procedures required by section 268 of the *Municipal Act*, 2001 have been carried out;

AND WHEREAS the Council The Corporation of the City of Brampton has heard in person or by counsel, solicitor or agent, all persons claiming that their land will be prejudicially affected by this by-law and who applied to be heard;

NOW THEREFORE the Council of The Corporation of the City of Brampton **ENACTS AS FOLLOWS**:

- 1. The Lands are hereby declared to be surplus.
- 2. The transfer for nominal consideration of the Lands to The Regional Municipality of Peel is hereby authorized and the City Solicitor is hereby authorized to execute all documents and instruments as may be necessary to effect the conveyance of the said lands.

READ a **FIRST**, **SECOND** and **THIRD TIME** and **PASSED** in Open Council this 26th day of May, 2003.
