AMENDMENT NUMBER OP93 - __91 TO THE OFFICIAL PLAN OF THE CITY OF BRAMPTON PLANNING AREA

1.0 Purpose:

The purpose of this amendment is to change the land use designation of the lands shown outlined on Schedule "A" to this amendment to permit the development of the subject lands for "Prestige Industrial" purposes.

2.0 Location:

The lands subject to this amendment have a total area of 8.75 hectares (21.6 acres) and are located on the north side of Nevets Road between Airport Road and Delta Park Boulevard within Part of Lot 5, Concession 7, Northern Division, in the City of Brampton.

3.0 Amendments and Policies Relative Thereto:


- 3.1 The document known as the Official Plan of the City of Brampton Planning Area is hereby amended:
 - (1). by adding to the list of amendments pertaining to Secondary Plan Area Number 37: The Airport Road/ Highway 7 Business Centre Secondary Plan as set out in Part II: Secondary Plan, Amendment Number OP93- 91
- 3.2 The portions of the document known as the 1984 Official Plan of the City of Brampton Planning Area which remain in force, as they relate to the Airport Road/Highway 7 Business Centre Secondary Plan (being Chapter 37 and schedules SP37(a) and (b)) are hereby further amended:
 - (1). by changing on Schedule SP37(a) thereto, the land use designation of the lands shown outlined on Schedule "A" to this amendment from "Intermediate Office" and "Office Centre" to "Prestige Industrial".
 - (2). by deleting from the legend of Schedule SP37(A) the land use designation of "Special Policy Area No. 1"

(3). by deleting therefrom, section 3.8.1 in its entirety.
