BY-LAW

Number 147-77

A BY-LAW TO PROVIDE FOR THE
ERECTION OF YIELD RIGHT-OF-WAY
SIGNS AT INTERSECTIONS.



WHEREAS IT IS DEEMED EXPEDIENT TO REGULATE TRAFFIC BY THE
ERECTION OF YIELD RIGHT-OF-WAY SIGNS IN COMPLIANCE WITH THE
REGULATIONS OF THE HIGHWAY TRAFFIC ACT R.S.O. 1970.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF
BRAMPTON ENACTS AS FOLLOWS :

1. THE INTERSECTIONS ON HIGHWAYS SET OUT IN COLUMN 1 OF
SCHEDULE "A" HERETO ARE DESIGNATED AS INTERSECTIONS WHERE
YIELD RIGHT-OF-WAY SIGNS SHALL BE ERECTED FACING TRAFFIC
IN THE DIRECTION SET OUT IN COLUMN 2 OF THE SAID SCHEDULE.
2. THE PENALTIES PROVIDED IN SECTION 152 OF THE HIGHWAY
TRAFFIC ACT, R.S.O. 1970, CHAPTER 202, SHALL APPLY TO
OFFENCES AGAINST THIS BY-LAW AS GOVERNED BY SECTION
90 (1) OF THE SAID ACT.
3. (A) SUBJECT TO SUBSECTION (B) THIS BY-LAW SHALL NOT BECOME
EFFECTIVE UNTIL APPROVED BY THE REGIONAL MUNICIPALITY OF
PEEL.

(B) THAT PART OF THE BY-LAW AFFECTING TRAFFIC ON MAIN STREET
(NORTH AND SOUTH) AND QUEEN STREET EAST WHICH ARE DESIGNATED
AS CONNECTING LINKS UNDER THE PUBLIC TRANSPORTATION AND
HIGHWAY IMPROVEMENT ACT, SHALL NOT BECOME EFFECTIVE UNTIL
APPROVED BY THE MINISTRY OF TRANSPORTATION & COMMUNICATIONS.
4. THAT BY-LAW NUMBER 40-74 AND ALL AMENDMENTS THERETO ARE
HEREBY REPEALED.
