1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by deleting from Schedule X thereto the following item.

COLUMN 1 HIGHWAY	COLUMN 2 RATE OF SPEED	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Kennedy Road South	40	Steeles Avenue East and Hartford Trail	Anytime

(2) by adding to Schedule X thereto the following item:

COLUMN 1 HIGHWAY	COLUMN 2 RATE OF SPEED	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Kennedy Road South	60	Steeles Avenue East and a point 150 metres south of Steeles Avenue East	Anytime
Kennedy Road South	40	a point 150 metres south of Steeles Avenue East and Hartford Trail	8:00 am to 5:00 pm on school days
Kennedy Road South	60	a point 150 metres south of Steeles Avenue East and Hartford Trail	Except 8:00 am to 5:00 pm on school days

2. Section (1), subsections (1) and (2) of this by-law shall not come into force until approved by the council of the Regional Municipality of Peel.




