Loading Zone at Earnscliffe
Senior Public School

The Council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by adding to Schedule XV thereto the following items:

NO STOPPING

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Earnscliffe Circle	East	A point 136 metres east/south of Edenridge Drive (northerly intersection) and a point 221 metres east/south of Edenridge Drive (northerly intersection)	8:00 am to 5:00 pm Monday to Friday
Earnscliffe Circle	West	A point 116 metres east/south of Edenridge Drive (northerly intersection) and a point 276 metres east/south of Edenridge Drive (northerly intersection)	2:30 pm to 4:00 pm Monday to Friday

(2) by adding to Schedule VIII thereto the following item:

SCHOOL BUS LOADING ZONE


COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 SCHOOL OR INSTITUTION
Earnscliffe Circle	East	A point 136 metres east/south of Edenridge Drive (northerly intersection) and a point 221 metres east/south of Edenridge Drive (northerly intersection)	Earnscliffe Senior Public School

2. Subsection (2) of this by-law shall not come into force until approved by the council of the Regional Municipality of Peel.

Earnscliffe Circle	East	A point 136 metres east/south of Edenridge Drive (northerly intersection) and a point 221 metres east/south of Edenridge Drive (northerly intersection)	8 00 am to 5:00 pm Monday to Friday
Earnscliffe Circle	West	A point 116 metres east/south of Edenridge Drive (northerly intersection) and a point 276 metres east/south of Edenridge Drive (northerly intersection)	2:30 pm to 4 00 pm Monday to Friday

(2) by adding to Schedule VIII thereto the following item:

SCHOOL BUS LOADING ZONE

Earnscliffe Circle	East	A point 136 metres east/south of Edenridge Drive (northerly intersection) and a point 221 metres east/south of Edenridge Drive (northerly intersection)	Earnscliffe Senior Public School
