BY-LAW

Number 150-2013

A By-law to amend the Schedules of Traffic By-law 93-93, relating to THROUGH HIGHWAYS (Schedule III), STOP SIGNS (Schedule IV), and RATE OF SPEED (Schedule X)

The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended by DELETING the following items from Schedule III:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Don Minaker Drive	The north limit of Ebenezer Road and the west limit of Gallucci Crescent (westerly intersection)
Jordensen Drive	The south limit of the roadway and the west limit of Valleyway Drive
Meltwater Crescent	The south limit of Riseborough Drive (westerly intersection) and the south limit of Riseborough Drive (easterly intersection)
Mistymorning Drive	The east limit of Airport Road and the east limit of the roadway
Fairlawn Boulevard	The west limit of Humberwest Parkway and the south limit of the roadway

2. By-law 93-93, as amended, is hereby further amended by ADDING the following items to Schedule III:

Jordensen Drive	The west limit of Valleyway Drive and the north limit of Abbotsbury Drive
Jordensen Drive	The south limit of Abbotsbury Drive and the south limit of the roadway
Meltwater Crescent	The south limit of Riseborough Drive (westerly intersection) and the west limit of Long Branch Trail
Meltwater Crescent	The east limit of Long Branch Trail and the south limit of Riseborough Drive (easterly intersection)

Mistymorning Drive	The east limit of Airport Road and the west limit of Relton Circle
Ricardo Road	The west limit of Relton Circle and the west limit of Fairlawn Boulevard
Fairlawn Boulevard	The west limit of Humberwest Parkway and the north limit of the Ricardo Road

3. By-law 93-93, as amended, is hereby further amended by ADDING the following items to Schedule IV:





Meltwater Crescent	40	A point 71 metres south of Riseborough Drive and a point 23 metres north of Washburn Road	Anytime
Riverstone Drive	40	McVean Drive and Don Minaker Drive	Anytime
Wardsville Drive	40	A point 26 metres west of Sky Harbour Drive and Financial Drive	Anytime
