



THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 157-2008

To amend By-law 399-2002, as amended,
The Sign By-law

WHEREAS the City of Brampton has adopted a Wayfinding and Signage Program which establishes guidelines for corporate outdoor signage;

WHEREAS the Wayfinding and Signage Program will be applied to all signage on public uses owned or leased by the City of Brampton; and

WHEREAS as a similar exemption exists within the Zoning By-law to permit public uses in all zoning categories subject to some restrictions;

NOW THEREFORE The Council of the Corporation of the City of Brampton ENACTS as follows.

1. THAT By-law 399-2002, as amended, is hereby further amended

- a) by adding the following sentence to Section 4 DEFINITIONS:
(57) "**Public Uses**" shall mean uses that are owned or leased by the City for community, recreational, administrative, educational, health care, protection, utility or other governmental purposes, and includes accessory uses to public use.

b) by adding the following Section:

EXEMPTIONS FOR SIGNS ON PUBLIC USES OWNED OR LEASED BY THE CITY

10. Public Uses owned or leased by the City are exempt from the following provisions of this by-law:

SCHEDULE II GROUND SIGNS;

SCHEDULE III WALL SIGNS;

SCHEDULE IV AWNING SIGNS & CANOPY SIGNS;

and

SCHEDULE V OVERHEAD SIGNS

with the exception of the following provisions:

- (a) For ground signs the distance from the finished grade to the bottom of the sign shall be either less than 0.15 m (6 in) or greater than 2.4 m (7.9 ft);
- (b) For ground signs a minimum distance of 1.5 m (5 ft) shall be provided from all property lines;
- (c) The street number of the property shall be displayed on each main *ground sign* on the street frontage in which the property is addressed, in order to identify the municipal address of the property. The street number shall be prominently displayed and have a

minimum number height of 0.15 m (6 in) and a maximum number height of 0.5 m (1.6 ft). Where the *ground sign* is non-illuminated, the street number shall be of a reflective material.; and

(d) For wall, awning, canopy or overhead signs a minimum clearance of 2.4 m (7.9 ft) shall be maintained from finished grade to the bottom of the sign.

2. THAT By-law 399-2002, as amended, is hereby further amended by changing the numbering sequence of each section following the above added section.

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL, this **25** day of **June, 2008**
