NO PARKING RESTRICTIONS ON SPECIFIED HIGHWAYS,  
THROUGH HIGHWAYS, AND  
PEDESTRIAN CROSSOVERS

The council of the Corporation of the City of Brampton hereby  
ENACTS as follows:

1. By-law 193-83, as amended, is hereby further amended:

(1) by adding to the specified columns of Schedule I  
thereto the following items:

### NO PARKING ON SPECIFIED HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Kennedy Road South	Both	Steeles Avenue East to a point 323 metres south of Hartford Trail/ First Gulf Boulevard	Anytime
Torrone Street	West	Queen Street East and John Street	Anytime

(2) by adding to the specified columns of Schedule VIII  
thereto the following items:

### THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Clipstone Court	The south limit of the road and the west limit of Murray Street.

(3) by adding to the specified columns of Schedule XIV thereto the following items:

PEDESTRIAN CROSSOVERS

COLUMN 1  
HIGHWAY

COLUMN 2  
LOCATION

Central Park Drive


At the east side of the intersection with Greenarrow Court
