BY-LAW

Number 158-2002

To amend By-law 200-82, as amended.

The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-law 200-82, as amended, is hereby further amended:
 - (1) by adding to Section 108.1 the following:

“or

 - (2) a place of worship for a period of two years from June 10, 2002.”
 - (2) by renumbering Section 108.2 to Section 108.3
 - (3) by adding thereto the following:

“108.2 The use permitted under Section 108.1-(2) shall be subject to the following requirements and restrictions:


 - a) the worship area shall not exceed 117.6 square metres;
 - b) a minimum of 11 parking spaces shall be provided on the site.”

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL, this 10th day of June 2002.
