BY-LAW

Number _____ 160-88

To change the name of Berisford Drive on Plan 43M-815

WHEREAS the Council of the City of Brampton deems it expedient to change the name of Berisford Drive;

AND WHEREAS notice of the intention to pass this by-law has been published once a week for four successive weeks in The Brampton Guardian and the Brampton Times, newspapers having general circulation in the City of Brampton;

AND WHEREAS the Council has heard all persons who claimed that they would be adversely affected by this by-law and who applied to be heard;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. The name of the street shown as "Berisford Drive" on Registered Plan 43M-815, which is described in Schedule A attached hereto, is changed to "Wayne Nicol Drive".

2. The affidavit of Leonard J. Mikulich attached as Schedule B hereto shall form part of this by-law.
