BY-LAW

Number 169-89

A by-law applicable to
part of the area subject
to By-law 200-82 (Central
Area)

The Council of The Corporation of the City of Brampton
ENACTS as follows:

1. By-law 200-82, as specifically amended by By-law 183-87
and By-law 270-87, is hereby further amended:

- (1) by deleting therefrom section 20.4.1;
- (2) by renumbering section 20.4.2 and section 20.4.3
thereto, as section 20.4.1 and section 20.4.2;
- (3) by deleting therefrom, the first paragraph of
section 20.4.1 and substituting therefor the
following:

"20.4.1 Parking spaces are required in Commercial
Zones within the Central Area, in accordance
with the requirements of section 20.3 and
the following:"

- (4) by adding thereto, the following as section 20.4.3:


"20.4.3 The lands shown outlined and identified as
"Parking Exemption Area" on Schedule B-2 to
this By-law shall be exempt from the
parking requirements set out in section
20.4"

- (5) by adding thereto, the following as section 20.4.4:

"20.4.4 The lands shown outlined and identified as
an "Interim Parking Exemption Area" on
Schedule B-2 to this by-law shall be
exempt from the parking requirements of
section 20.4, only for a one (1) year
period expiring June 12, 1990.

(6) by deleting therefrom, Schedule B-2 , and substituting therefor Schedule A to this by-law.

READ a FIRST, SECOND, and THIRD TIME and PASSED in OPEN COUNCIL this 12th day of June , 1989.

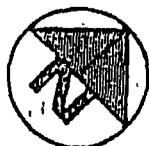


LEGEND
