



THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 171-77

TO AMEND BY-LAW NUMBER 187-75
TO PRESCRIBE SPEED LIMITS ON
PORTIONS OF CERTAIN HIGHWAYS.

WHEREAS THE COUNCIL OF THE CORPORATION OF THE CITY OF BRAMPTON
DEEMS IT EXPEDIENT AND ADVISABLE TO AMEND BY-LAW NUMBER 187-75,
BEING A BY-LAW TO PRESCRIBE SPEED LIMITS ON PORTIONS OF CERTAIN
HIGHWAYS.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF
BRAMPTON ENACTS AS FOLLOWS:

1. THAT SCHEDULE "A" TO BY-LAW NUMBER 187-75 BE AMENDED BY THE
DELETION THEREFROM OF THE FOLLOWING UNDER THE APPROPRIATE
COLUMNS THEREOF:

MAXIMUM RATE OF SPEED 35 M.P.H.

<u>HIGHWAY</u>	<u>FROM</u>	<u>TO</u>
CREDITVIEW ROAD	STEELES AVENUE	A POINT 800 FT. SOUTH OF HALLSTONE ROAD

2. THAT SCHEDULE "A" TO BY-LAW NUMBER 187-75 BE AMENDED BY THE
ADDITION THERETO OF THE FOLLOWING UNDER THE APPROPRIATE
COLUMNS THEREOF :

<u>HIGHWAY</u>	<u>FROM</u>	<u>TO</u>
CREDITVIEW ROAD	STEELES AVENUE	A POINT 2,100 FT. SOUTH OF HALLSTONE ROAD.

3. THAT SCHEDULE "B" TO BY-LAW NUMBER 187-75 BE AMENDED BY THE
DELETION THEREFROM OF THE FOLLOWING UNDER THE APPROPRIATE
COLUMNS THEREOF :

MAXIMUM RATE OF SPEED 40 M.P.H.

<u>HIGHWAY</u>	<u>FROM</u>	<u>TO</u>
CREDITVIEW ROAD	A POINT 800 FT. SOUTH OF HALLSTONE ROAD	THE SOUTHERLY LIMIT OF THE CITY OF BRAMPTON.

4. THAT SCHEDULE "B" TO BY-LAW NUMBER 187-75 BE AMENDED BY THE ADDITION THERETO OF THE FOLLOWING UNDER THE APPROPRIATE COLUMNS THEREOF :

<u>HIGHWAY</u>	<u>FROM</u>	<u>TO</u>
CREDITVIEW ROAD	A POINT 2,100 FEET SOUTH OF HALLSTONE ROAD.	THE SOUTHERLY LIMIT OF THE CITY OF BRAMPTON.

5. THE PROVISIONS OF THIS BY-LAW SHALL NOT BECOME EFFECTIVE UNTIL APPROVED BY THE COUNCIL OF THE CORPORATION OF THE REGIONAL MUNICIPALITY OF PEEL.
