TO AMEND BY-LAW NUMBER 187-75 TO PRESCRIBE SPEED LIMITS ON PORTIONS OF CERTAIN HIGHWAYS.

WHEREAS THE COUNCIL OF THE CORPORATION OF THE CITY OF BRAMPTON DEEMS IT EXPEDIENT AND ADVISABLE TO AMEND BY-LAW NUMBER 187-75, BEING A BY-LAW TO PRESCRIBE SPEED LIMITS ON PORTIONS OF CERTAIN HIGHWAYS.

BY-LAW 171-77 AMENDS BY-LAW 187-75
